

# COVERING CONDITIONS 2026

## Askur frá Finnsstaðaholti



The general terms and conditions apply to all coverings through Hengstenhouderij van Nunen in 2026. The studfee is exclusive VAT, shipping costs and any documents. By registering the mare owner declares to have taken note of our breeding and payment conditions and agrees to these conditions.

### EU station | EG226804

Hengstenhouderij van Nunen is an approved EU-station.

### Insemination

Askur is available through artificial insemination (AI) - fresh semen.

### Delivery

- Mare will come to Hengstenhouderij van Nunen for insemination.
- Semen will be sent to mare owner (EU)

### Covering period

01-04-2026 until 30-09-2026

### Bookingfee

The bookingfee is €300 excl VAT. The bookingfee is non refundable and must be booked before the mare is brought or semen is ordered. When the mare is scanned pregnant the bookingfee will be withdrawn from the total studfee.

### Bacteriological test

We recommend a swab from the uterus. This test can be taken at home before arrival or at Hengstenhouderij van Nunen. If the mare is unclean on the swab it is possible to have her treated here.

### Mare will come to Hengstenhouderij van Nunen

### Upon arrival

- The mare is brought without shoes and with well-groomed hooves.
- The mare is correctly vaccinated and the passport is delivered to Hengstenhouderij van Nunen.
- If the mare has eczema, bring the eczema blanket.
- The mare is healthy and recently dewormed.

### Health

The mare owner guarantees that the mare/foal has not been in the vicinity of other horses with or symptoms of druse for the past 3 months.

The mare owner guarantees that the mare/foal or any other horse which the mare/foal have been in contact with in the past 6 weeks, have not shown signs of infectious diseases.

### During stay

Mares are inseminated, scanned and treated at the expense and risk of the mare owner.

Hengstenhouderij van Nunen reserves the right to call a veterinarian at our discretion at the owner's expense.

Mares with aggressive behavior or are difficult to catch are moved to a separate paddock at the owner's expense.

The mare-owner gives mandate for us to transport the horse if necessary.

### Semen will be sent to mare owner

### Semen order

Semen can be ordered via the order form on our website or by e-mail via [info@hengstenhouderijvannunen.com](mailto:info@hengstenhouderijvannunen.com)

Semen must be ordered before 09:00AM. Orders after this time will be processed the next day.

### Semen order

Semen can be ordered with a maximum of 2 times per heat.

The mare owner is obliged to pay the costs from the moment of the first order. No new order can be placed if payment has not been made.

The semen which is supplied may only be used to inseminate the mare specified in the order/booking.

The semen may not be passed on to third parties.

### Packaging

Semen for shipment or pick-up will be packed in suitable packaging, which is the property of Hengstenhouderij van Nunen. Please return the semen shippingbox to Hengstenhouderij van Nunen.

### Semen order

Semen can be ordered from Monday - Friday before 9:00AM.

### Delivery

Semen will be delivered the **same day** in:

- The Netherlands | Part of Germany | Belgium | Luxembourg | France

### Delivery

Semen will be delivered the **next day** in:

- Part of Germany | Austria | Swiss | Denmark | Norway | Sweden | Finland

Semen cannot be delivered on public holidays.

### Shipping costs

Shipping costs and health papers (Traces) required by EU semen dispatch abroad are at the mare-owner's expense.

### General

### Pregnancy ultrasound

Mares must be scanned for pregnancy between 15 and 21 days after ovulation and results must be reported to Hengstenhouderij van Nunen immediately after. The remaining amount for the covering and other expenses will be invoiced when the mare is +15 days pregnant. Payment period of 14 days.

### Fresh semen

We work with fresh semen. If a stallion becomes unavailable during the breeding season for any reason (such as illness or injury), the use of another stallion will be offered at the rate of the replacement stallion. The bookingfee remains non-refundable in all cases.

In case of limited semen availability, priority will be given in order of registration.

### Covering registration

The covering certificate will only be issued to the relevant studbook once all outstanding fees have been fully paid.

**Non-pregnancy**

If the mare resorbs before the 45th day of pregnancy (from date of last insemination), van Nunen will issue a credit note of the 'by pregnancy' part of the studfee (bookingfee will not be refunded). Provided that a veterinary certificate of non-pregnancy is presented to van Nunen before the 45th day of pregnancy. If the certificate is not submitted in time, the issue of a credit note is not possible.

**Liability**

Hengstenhouderij van Nunen accepts no liability for delayed and/or (too) late delivery of the ordered semen.

**Liability**

Hengstenhouderij van Nunen does not accept any liability for damage, illness (including, but not limited to: Druse/CEM/Rhino and so on) and/or injury to people, animals, means of transport or otherwise. Horses are handled, covered & stabled at owner's risk. The mare-owner is responsible for all possible costs.

**Registering**

By registering the mare, the mare owner confirms acceptance of the covering conditions and general conditions of Hengstenhouderij van Nunen.
